

Rental Requirements

Income Requirements:

- Applicants must have a current, verifiable gross income of three times (3), the amount of the rental rate for the unit for which the applicant applies for.
- Applicants must provide paycheck stubs as <u>proof of income</u>, 2-3 <u>current months</u>. If selfemployed, applicant to provide the most <u>current income tax returns</u>, and/or additional supporting documentation.

Credit History:

- A credit check and unlawful detainer registry check will be run on all applicants.
- Applicants must have good credit. We look for a minimum score of 650.
- We do not accept "reusable tenant screening reports" from a third party.

References:

Applicants must have positive rental history, and employment references.

Additional Requirements:

- Applicants must provide valid photo identification.
- Initials funds for move-in (security/holding deposit and the first months' rent) must be paid with a cashier's check or money order.

Security Deposits:

Security deposits are up to twice the monthly rent.

<u>Please Note!</u> There is a \$35.00 application screening fee per applicant, payable in cash/money order/cashier's check/Venmo. The \$35.00 fee is non-refundable fee. This fee is NOT collected until you have toured the property which you are applying for.

Each applicant 18+ years of age is required to complete an application.
